Assets acquired by TMX Funding include: (a) all goods consisting of inventory, equipment and fixtures wherever located in the world, including but not limited to Malaysia, Hong Kong and The United Kingdom; (b) all URL addresses owned or controlled by Teledex; (c) all tradenames owned or controlled by Teledex; (d) all schematics, designs and other technical information owned, licensed or controlled by Teledex; (e) all telecommunication numbers, including all telephone and facsimile numbers, issued to Teledex; and (f) all accounting data and information, but not including any accounting software or software licenses.

"This landmark brand consolidation represents a milestone in hotel guestroom telephony and confirms our commitment to continue to play a significant role in this global process," states Bing N. Sun, Ph.D., President & Chief Executive Officer, Scitec, Inc./TeleMatrix, Inc. This is not only a bold step for us, but a positive development for our customers, channel partners, and employees.
